#### PUBLIC HOUSING FAMILY SELF-SUFFICIENCY GRADUATE

Shavonda Hearn is a quiet hard working single parent with three children. She is also enrolled in the GED classes at night and very close to obtaining her General Equivalency Diploma.

Shavonda voluntarily enrolled in MHA's Public Housing Family Self Sufficiency Program August 1, 2010. When she enrolled in the Family Self Sufficiency Program, she wanted to take charge of her future but did not know where to start. The Family Self-Sufficiency (FSS) coordinator, along with the FSS participant, developed a step by step plan of action to assist them in the completion of their goals. Shavonda needed a GED to obtain better employment, homeownership, credit counseling as well as financial budgeting education. She was determined to use resources that were available at Meridian Housing Authority to improve her quality of life. The

Community and Supportive Services Department held workshops to provide information concerning homeownership, financial literacy, and job training/readiness/search. When Shavonda did not have to work, she attended every workshop that was offered.

Sounds like she was self-motivated to change her present life circumstances and determined to free herself from having to depend on public assistance.

Shavonda most important goal was to own her own home. Meridian Housing Authority is partnered with Multi-County and in a collaborative effort hosted a homeownership workshop last year where Shavonda received a certificate for completion of the homebuyer's workshop.

As of February 1, 2013, Shavonda and her three children are enjoying their lovely new home with three bedrooms and one bath.

#### **Residents of Carousel Place Participates in Drug-Free Art Contest**


The Carousel Place Housing Community sponsored a Drug-Free Art Contest for the youth resi-


