### Congratulations to the 2014 MHA ESTEEM Graduates



## **Executive Director's Message**

The Meridian Housing Authority (MHA) and the Meridian Police Department (MPD) are striving to make affordable housing neighborhoods safer and remain committed to strengthening all of Meridian's public housing communities.

National statistics show that public safety is enhanced tremendously when police officers live within the neighborhood. Therefore, agencies are pleased to report the success of the "Officer Next Door Program" approximately one year after its inception.

The Program was created to provide safer neighborhoods by allowing MHA to lease dwelling units to Meridian Police Officers. This collaborative effort began last year in Eastern Gardens, Western Gardens, Frank Berry Courts and the Carousel Place apartments.

Certified police officers are permitted to lease an apartment for a twelve-month period at no cost to the officers. The MPD ensures that officers involved in the program will maintain a high visibility level through active participation in resident association meetings, daily MPD vehicle patrolling and the utilization of other community policing measures authorized by the MPD. Police Chief. MHA ensures that all participants are familiar with the special lease agreement. The officers must also reside in the apartment as their primary source of residency during the lease contract period.

### Carousel Place Smoke-Free Soon

Carousel Place begins making preparation for a smoke-free property effective October 1, 2014. Residents and guests at The Carousel Place will no longer be allowed to smoke in housing units.

During this transition, smoking will however be permitted on outdoor property including porches. Residents are reminded of the guidelines in the signed lease addendum that states that infractions will be issued accordingly if evidence of smoking is discovered in housing units.

Residents are encouraged to focus on the positive outcomes that will yield having a smokefree property. A smoke-free property assists with keeping rental cost down, improves personal health, and is great for the environment. Ultimately, everyone will benefit from this change.

Effective January 1, 2015, smoking will only be allowed in the designated smoking area.

Management and staff encourage all residents to adhere to the new policy. Many more workshops and informative sessions will be held to assist residents in preparing

#### **Trick or Treat**

Its that time of year again, Trick or Treat. Everyone loves a good scare on Halloween but not when it comes to injuries and safety. Halloween is one of the most favorite holidays for children and teenagers.

There are several easy and effective behaviors that parents can share with their kids to help them reduce their risk of injury.

Safety is always first at Meridian Housing Authority. Halloween is Friday, October 31st and we are looking forward to all MHA residents having a great and fun time while trick or treating without encountering any serious injuries.

Unintentional pedestrian injuries are the fifth leading cause of injury-related death in the United States for children ages 5 to 19.

Teenagers are now at greater risks. Teens have a death rate twice that of younger children and account for half of all child pedestrian deaths. Here are some safety tips for teenagers while trick or treating. These tips can also be used for any child who will participate in trick or tricking this year.

- Please make sure all costumes and Halloween bags have some sort of reflective tape or stickers
- If at all possible, wear light color clothing
- Make sure children can see clearly through the eyes of the mask
- Use non-toxic face paint and make up
- Please caution your children not to eat open candies and wait until they return home to allow you to inspect all candies
- Make certain that their costumes are safe and allow them to be see and to be seen after dark
- Make sure you know where your children are going and to have an adult to accompany them while they are trick or treating
- Be aware of your surroundings and notify the proper authorities during an emergency, or if you suspect any criminal activities or behaviors taking place

It is always good to remain safe in a safe environment.

With the implementation of HUD's mandatory Section 210 Ruling, there remains some concerns among the residents regarding the HUD Appropriations Act of 2014, which revised the Flat Rent Table for public housing residents. Information received regarding this

HUD requirement has revealed that many residents may have failed to obtain a copy of the HUD 210 Ruling. A copy of this mandatory regulation is available upon request and located in your manager's office. Also there will be ongoing reviews of HUD's 210 Ruling at your upcoming tenant meetings.

If you have any questions regarding the mandatory HUD Section 210 Ruling, please feel free to contact your property manager for clarification on this important matter.

Make sure you receive a copy of the new Flat Rent Tablet to determine the affects it may have on your household.
