Breast cancer is the most common non-skin cancer among American women. One in eight women will develop invasive breast cancer during her lifetime. But advances in breast cancer treatment mean many women can expect to beat the disease and maintain their physical appearance.

To show our support, beginning October 2, 2015, Meridian Housing Authority employees wore pink throughout the month of October. Each Friday at MHA, all the staff participated in "PINK FRIDAY." On Pink Friday each department was responsible for a

table display that symbolized their support for cancer awareness. The display included informational pamphlets, pink pencil and pink pens. Breast Cancer Awareness Display at MHA Central Office


- Breast cancer is the second leading cause of death among women.

## **MHA Liaison Officers Encourages** Safety

Meridian Housing Authority police liaison offiers are advising all residents to practice safety precautions in performing daily activities. These neasures will ensure a better quality of life for all esidents and make the community a safer place.

Please be reminded that the City of Meridian has a curfew schedule for all minors under the age of 18. MHA liaison officers will be strictly enforcing he curfew hours through out MHA affordable nousing communities. A summary of the city's youth and local ordinance is cited below.

"It shall be unlawful for any minor under eighteen (18)years of age to retain in or upon any public street, highway, park, vacant lot or other public place within the city between those hours beginning at 10:00 p.m. to 6:00 a.m. next following, Sundays through Thursdays, and between those hours beginning at 12:00 a.m. (midnight) on Saturdays to 6:00 a.m. next following."

 "It shall be unlawful for any compulsory school age child to remain or upon any street, highway, park, vacant lot or other place within the city during the following period: 8:45 a.m. until 2:45 p.m. on Monday, Tuesday, Wednesday, Thursday and Friday during the school term in which [a] compulsory school age child is enrolled in a public or private legitimate non—public school, as required by the Mississippi Compulsory School Attendance Law (Section 37-13-19)."

We hope that each resident will adhere to the curfew hours cited above. With your cooperation all MHA properties will remain safe for all of our residents.
