On April 14, 2018 the City of Meridian experienced an EF-2 tornado which caused over \$1.5 million dollars in property damage throughout five of Meridian Housing Authority's affordable housing communities. Eight families were relocated from the George Reese Court "L" building. Mr. Marshall McKey, resident president, states that he is pleased with the progress made in his community. The building is projected to be fully restored by November 15, 2018. Ms. Rosie McClelland an icon in the George Reese Court Community for over 35 years states that she is anxious to return home.

On October 18, 2017 the Department of Housing and Urban Development (HUD) awarded MHA with a competitive safety and security grant in the amount of \$189,000.00.

Surveillance and security systems were installed and are currently fully operational in the following communities: Highway Village, Western Gardens, Oakland Heights, Eastern Gardens, and Sowashee Courts. Plans are also underway to install surveillance systems at Magnolia Courts, Mountain View Village, Mount Barton and several of the agency's scattered site locations. Hats off to MHA's Resident Advisory Board for their valuable input in the strategic planning of this initiative.

I would also like to take this time as we prepare to celebrate this holiday season, to wish MHA Board of Commissioners, MHA Resident Advisory Board Members, MHA Community Partners, MHA Residents and staff the very best of times and family enjoyment. STEP 2: PULL PIN

STEP 3: AIM AT BASE OF FIRE

STEP 4: SQUEEZE HANDLE

STEP 5: SWEEP FROM SIDE TO SIDE

High School Student of the Month


